The quotation that complies with all of the specifications, requirements and offers the lowest price, as well as all other evaluation criteria indicated, shall be selected. Any offer that does not meet the requirements shall be rejected. Any discrepancy between the unit price and the total price (obtained by multiplying the unit price and quantity) shall be re-computed by WUFBON.

The unit price shall prevail and the total price shall be corrected. If the supplier does not accept the final price based on WUFBON's re-computation and correction of errors, its quotation will be rejected. After WUFBON has identified the lowest price offer, WUFBON reserves the right to award the contract based only on the prices of the goods in the event that the transportation cost (freight and insurance) is found to be higher than WUFBON's own estimated cost if sourced from its own freight forwarder and insurance provider. At any time during the validity of the quotation, no price variation due to escalation, inflation, fluctuation in exchange rates, or any other market factors shall be accepted by WUFBON after it has received the quotation.

At the time of award of Contract or Purchase Order, WUFBON reserves the right to vary (increase or decrease) the quantity of services and/or goods, by up to a maximum twenty five percent.

Service providers must be having TIN numbers as a must.

Existing service providers to lower local government for meals and refreshments + stationary are highly encouraged to apply provided they have previous experience and trust by the recommended district local government or District Interfaith hub.
