

Western Uganda FBO Network is an interfaith umbrella network for FBOs in western Uganda, we are duly constituted by (Faith Based Organizations) FBOs working in Western Uganda. Our role is to complement Government programs in order to improve the well-being of people in Uganda and elsewhere in Africa.

From 2013 to date Western Uganda FBO Network has made significant improvements in priority areas: Organizational strategic management and quality, Organizational business process, Faith based fundamental and values of different faith backgrounds, internal and external communications, information technology, Monitoring, evaluation, learning and advocacy, fiscal management and stewardship, and workforce development. Our past and current work in these areas, and additionally focus on new opportunities to advance our mission and vision over the next five years.

As an inter-faith and inter-cultural organization working in Uganda, we are responsible for advancing PHED (Population Health Education & Development), Human rights protection, Health, Environment, safety and Mental Health of our residents in Uganda.

We have 10 districts interfaith hubs coordinating districts interfaith activities in districts mid-western Uganda with over 1,800 religious leader subscribers as well as 3 major sub regional interfaith hubs which are the

engines for our service delivery through mid-western and south western Uganda region. We employ a small number at the headquarters and decentralized our workforce through interfaith hubs and active faith-based organizations that provide direct services through 30 programs locations. To provide and facilitate strategic management of this extensive portfolio of work across several sectors of development in this changing global social, political, climatic and religious economy. We utilize a "Balanced Scorecard" system as the core of a robust performance management system which assures proper alignment of our plans, systems, and work with our mission, vision and values.

THE EXECUTIVE BOARD

The Executive board is the second highest organ of Western Uganda FBO Network as per the constitution of the network Article x.

- The network has co-opted to open a U.S.A not for profit charity/ to get registered as USA based organization with board member and representative from USA and an Executive Director for Fundraising and communication who will be added to the current WUFBON board and working groups of the organization.
- In this context Executive Director in charge of Programs in Uganda and Executive Director in charge of Fundraising and communication as well as the co-opted board member based in U.S.A shall be ex-officials of the executive in all sub committees of the network.
- Western Uganda FBO Network Executive Board has the following Functions.
 - 1. Ensure the network has all legal documents and complaint both in Uganda and in the U.S.A.
 - 2. Implement and further facilitate the realization of the objectives, policies and decisions of Western Uganda FBO Network as laid down by the general assembly.
 - 3. To consider reports submitted by the secretariate on the activities of Western Uganda FBO Network and make appropriate recommendations to the general assembly.
 - 4. To supervise affairs of the Western Uganda FBO Network.
 - 5. To appoint Directors and other technical staff of the secretariate
 - 6. To define the duties and determine renumeration of the members of staff.
 - 7. To supervise the performance of staff.
 - 8. To set up committees and taskforce as may be necessary to deal with specific issues pertaining to the functions of Western Uganda FBO Network and to co-opt such individuals as shall have the requisite expertise into such taskforce or sub-committee.
 - Consider and submit for approval to the general assembly, the budget of Western Uganda FBO Network
 - 10. To mobilize resources for Western Uganda FBO Network
 - 11. To invest Western Uganda FBO Network funds in line with criteria lead by the annual general meeting.

Time Commitment

In order to fulfil this position, Board members must be able to commit to the following:

- ➤ Participate in 3-5 online meetings each year (please note that Board members are located in countries all over the globe this means that meetings may be scheduled all hours of day and night as we strive to ensure time justice).
- Attend and actively participate at one in-person meeting (5 days) each year.
- > Review materials, participate in discussions and make timely decisions.

Qualification of Board Member Candidates

- ➤ Have direct involvement with Family Planning, environment, climate change, development, education, and human rights activism at the regional and/or international level.
- ➤ Have experience in decision-making bodies (e.g., Board or Steering Committees) composed of diverse stakeholders.
- Have experience with collective and participatory decision-making processes and be able and willing to work in a diverse environment that includes activists and donors.
- Have technical expertise and skills related to or applicable to running a non-profit participatory grant making fund (e.g., finance, legal, human resources, governance, communications, etc.)
- ➤ Be able to communicate and write in at least one of the Western Uganda FBO Network's working languages (English).
- ➤ Hold a passport and be able to travel internationally to attend Board meetings.
- Have a strong commitment to fulfilling tasks and adhering to deadlines.

Conflict of Interest

Board members or their family members cannot be significantly involved in any group that is applying for funding from the Western Uganda FBO Network. Board members may not benefit financially from the grants assessed or existing Western Uganda FBO Network grants in line with Western Uganda FBO Network conflict of Interest Policy.

Timeframe

Board members will be appointed for a three-year term renewable. The beginning of the engagement will be determined based on when the recruitment process is completed and when seats become available.

Compensation

Board members role at Western Uganda FBO Network is voluntary and board members often donate time and resources on top of volunteering.
